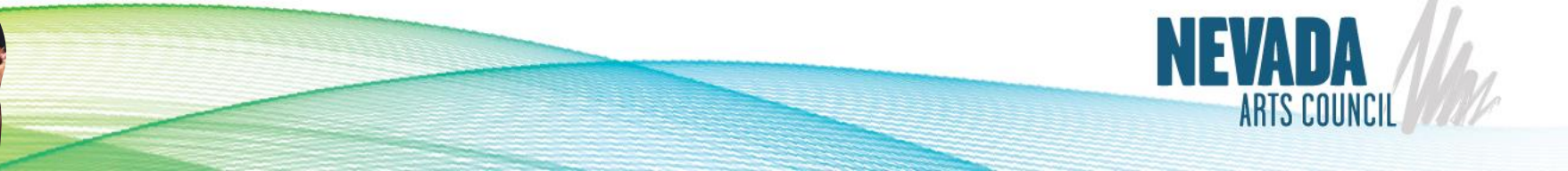

Grant & Award General Features

Always read the specific guidelines for the grant to which you are applying

Eligibility: Organizations

Non-profit Organization

- Must have federal tax-exempt status under Section 501(c)(3) of the Internal Revenue Code (Fiscal Agents are not accepted)
- Must have active incorporation status with the Nevada Secretary of State showing evidence of good standing at the time of application
- Must be based in Nevada*

* Border-state nonprofits may be eligible for Project Grant for Organizations

† Public institutions are ineligible for Operating Support Grant

Public Institution: Public Schools and Libraries†

- Individual schools and libraries within the same district or system may apply independently if they have their own budget and facility

Public Institution: Colleges†

- Limited to no more than one grant to the same academic department per fiscal year
- Projects must serve a broad community outside the institution and generate area-wide arts involvement
- Grants may not support the institution's internal programs

Eligibility: Individuals

- Must be a current Nevada resident and have been in residence for at least one year prior to the date of the grant application
- Must be a U.S. citizen or have legal permanent resident status
- Must be at least 21 years old
- Must not be enrolled as degree-seeking student in a field related to the type of grant
- Artists working in collaborations must file one joint application with one individual as the primary applicant*

* Artist Fellowship Award applicants must apply as individuals and present their own work

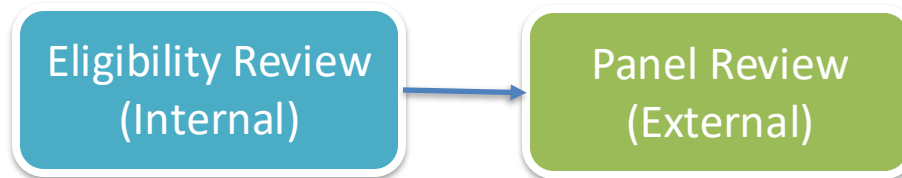

<ul style="list-style-type: none">• Nevada Arts Council staff reviews applications for eligibility, completeness, and adherence to the program requirements.• Applications that meet all eligibility and program requirements are awarded in the order in which they are received while funds remain available.• A record of the review process is maintained for all applications.	<ul style="list-style-type: none">• Arts Learning Express (ALX)• Folklife Community Grant (FLC)• Folklife Artist Grant (FLA)

Funding Amounts

Funding: Panel Review

- Panelists score grant applications and make funding recommendations to the Nevada Arts Council Board.
- Per Nevada Arts Council Board decision on September 20, 2019, grant applications with an average score of less than 70 will not be funded.

Funding: Internal Review

- Applications that meet all eligibility and program requirements are awarded in the order in which they are received while funds remain available.
- Grants are contingent on available funding as approved by the Nevada Arts Council Board.

All Applications

- Not all applications are funded, and grant awards may vary from requested amounts.

FY26 Project Grant for Artists

Providing project support for individual artists

- **Open to:** Individuals and Collaborative Groups
- **Application Open:** Jan. 2, 2025, 8 a.m. PT
- **Application Deadline:** March 3, 2025 at 5 p.m. PT
- **Grant Amount:** Up \$3,000 (no match required)
- **Time Period of Support:**
 - **Cycle A:** July 1, 2025 – December 31, 2025
 - **Cycle B:** January 1 – June 30, 2026
- Supports **individual artists** in the production and presentation of **artistic projects**.
- Examples of eligible projects include art exhibitions, performances, readings, concerts, the creation of art, portfolio creation, curation, and marketing/promotional activities related to an arts project.

FY26 Artist Fellowship Award

Recognizing Outstanding Individual Artists

- **Open to:** Individuals
- **Application Open:** March 3, 2025, 8 a.m. PT
- **Application Deadline:** May 1, 2025, 5 p.m. PT
- **Award Amount:** \$5,000
- Recognizes **committed artists** living in Nevada who **demonstrate sustained excellence** in their work and have reached pivotal moments in their artistic practice.
- Awarded as an **honorarium** and does not need to be used for any specific expenses or projects.
- By acknowledging outstanding artistic accomplishments across a body of work the program promotes **public awareness and appreciation** of the role of the artist in our society.
- In odd fiscal years the grant is open to **visual artists** and in even fiscal years it is open to **performing and literary artists**.

FY26 Arts Learning Project Grant

Supporting Arts Learning Activities for Pre-K – 12 and Lifelong Learning

- **Open to:** Nonprofits & Public Institutions
- **Application Open:** Feb. 3, 2025, 8 a.m. PST
- **Application Deadline:** April 1, 2025, 5 p.m. PST
- **Grant Amount:** Up to \$7,000 (1:1 cash or in-kind match required)
- **Time Period of Support:** July 1, 2025 – June 30, 2026
- Support **arts learning activities, teaching artists residencies, and teacher/teaching artists training** to provide unique opportunities for students and people of all ages to work with practicing artists.
- Funds must be used for **conducting lessons/workshops** (in-person or online/virtual); **educational performances** at schools or community facilities; the execution of **one activity/project or a series** of related activities.

FY26 Arts Learning Express

Supporting Short-Term Arts Education Programming

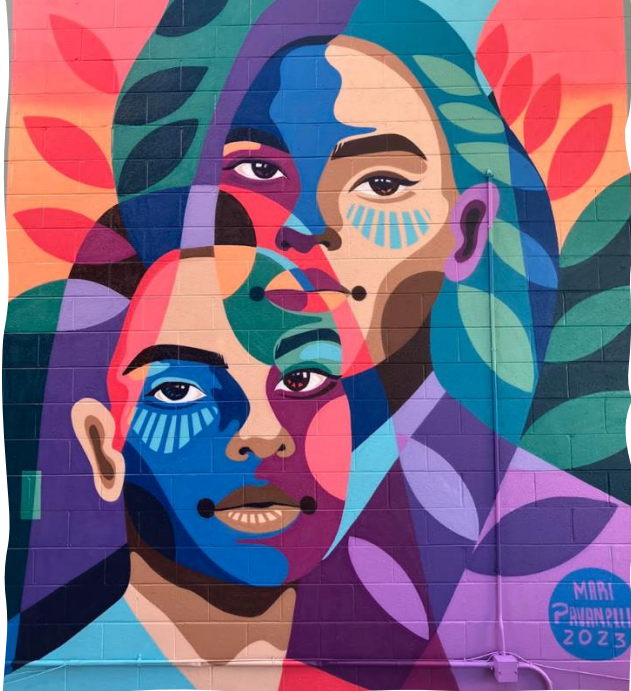
- **Open to:** Roster Teaching Artists, Nonprofits & Public Institutions
- **Grant Amount:** Up to \$2,000 (no match required)
- **Time Period of Support:**
 - **Cycle A:** July 1, 2025 – December 31, 2025
 - **Cycle B:** January 1 – June 30, 2026
- Supports **short-term arts education programming**. This grant is open to community organizations/public institutions and individual teaching artists who are **on the Nevada Arts Council Teaching Artist Roster**.
- To offer flexibility and expedite funding, ALX grants will be awarded on a **first come, first-served** basis for each cycle. Grant funds are limited, so early submission is encouraged.
- Eligible applicants can receive **up to two ALX grants per fiscal year, but only one ALX grant per cycle**. The **Final Report for the first grant must be submitted prior** to receiving funds for the second grant.

FY26 Teaching Artist Roster

Connecting teaching artists with schools and communities throughout Nevada

- **Open to:** Individuals, Collaborative Groups, Nonprofits
- Build a **network** of educators, teaching artists and cultural organizations to create diverse, innovative, and quality arts learning opportunities for all ages.
- Provide support for **formal and informal arts learning programs/projects** by artists and arts organizations to reach new communities and new populations.
- Promote **access to learning in and through the arts** as part of a well- rounded education for all Nevada's students.
- Promote **lifelong learning** in the arts for all Nevadans in all disciplines.

FY26 Project Grant for Organizations

Supporting arts and cultural projects with community impact

- **Open to:** Nonprofits & Public Institutions
- **Application Open:** Dec. 2, 2024, 8 a.m. PT
- **Application Deadline:** Feb. 3, 2025, 5 p.m. PT
- **Grant Amount:** Up to \$7,000 (1:1 cash or in-kind match required)
- **Time Period of Support:** July 1, 2025 – June 30, 2026
- Supports the arts and cultural activities of **organizations and public institutions**
- Funds may be used to support the execution of **arts and culture project(s)**
- Examples of eligible projects include art exhibitions, performances, readings, and festivals

FY26/27 Operating Support Grant

Supporting core operations of arts organizations

- **Open to:** Nonprofits with mission that describes the arts as the primary purpose of organization
- **Application Open:** May 1, 2025, 8 a.m. PT
- **Application Close:** July 1, 2025, 5 p.m. PT
- **Grant Amount:** Up \$50,000 (\$25,000/year) based on budget
- **Time Period of Support:**
 - **Year 1:** July 1, 2025 – June 30, 2026
 - **Year 2:** July 1, 2026 – June 30, 2027
- Operating Support Grants (OSG) strengthen Nevada's arts infrastructure by supporting general operations of non-profit arts organizations with ongoing, sustained, accessible programs and arts services or artistic programming in their communities
- OSGs are awarded on a two-year cycle. Organizations will submit a full application in even fiscal years, and an Interim Report in the following odd fiscal year

Supporting the work of Nevada’s folk artists and culture bearers

- **Open to:** Individuals and Collaborative Groups
- **Application Open:** May 1, 2025, 8 a.m. PT
- **Application Deadline:** At least 30 days before the proposed project (while funds remain available)
- **Grant Amount:** Up to \$3,000 (no match required)
- **Time Period of Support:** July 1, 2025 – June 30, 2026
- Supports traditional arts projects by **folk artists** and **culture bearers**
- Eligible projects focus on the **transmission of folk arts or traditions** that are practiced, valued, and shared within culturally specific communities in Nevada
- Eligible projects can be **learning-focused**, such as apprenticeships, mentorships, group learning activities, and cultural reclamation; or **presentation-focused**, such as exhibitions, performances, readings, concerts, and festivals focused on folk and traditional arts practices

FY26 Folklife Community Grant

Supporting the work of folk artists in Nevada communities

- **Open to:** Non-profit organizations
- **Application Open:** May 1, 2025, 8 a.m. PT
- **Application Deadline:** At least 30 days before the proposed project (while funds remain available)
- **Grant Amount:** Up to \$5,000 (no 1:1 cash or in-kind match required except for organizations with annual budgets over \$50,000)
- **Time Period of Support:** July 1, 2025 – June 30, 2026
- Supports programs with folk artists and culture bearers presented **by small community organizations**
- Eligible projects focus on the **transmission or presentation of folk arts or traditions** that are practiced, valued, and shared within culturally specific communities in Nevada
- Eligible projects include, but are not limited to festivals, cultural events, concerts, and gatherings that bring traditional artists, cultural specialists, and communities together

FY26 Nevada Heritage Fellowship

Recognizing our state's outstanding tradition bearers

- **Open to:** Individuals and Collaborative Groups
- **Application Open:** March 3, 2025, 8 a.m. PT
- **Application Deadline:** May 1, 2025, 5 p.m. PT
- **Award Amount:** \$5,000 (no match required)
- Recognizes **tradition bearers** living in Nevada whose body of work has contributed to Nevada's traditional arts heritage
- Awarded as an **honorarium** and does not need to be used for any specific expenses or projects
- By acknowledging outstanding cultural and artistic accomplishments across a body of work the program promotes public **awareness and appreciation** of the role of traditional arts in our society.

Grant Guidelines

Finding, understanding, and following Nevada Arts Council grant guidelines

Read carefully to understand...	Examples*
If your proposed project fits the intent of the grant →	PGO: “Supporting Arts and Cultural Projects with Community Impact ”
If your proposed project is eligible →	<ul style="list-style-type: none">• PGO: No arts learning• ALP: No private lessons• FLA/FLC: Must be folk art
If you/your entity are eligible →	<ul style="list-style-type: none">• 501c3: Good standing with IRS, NV Secretary of State• All Entities: UEI number assigned• Individual: 1-year Nevada residency, 21+ years old, citizen/resident
If your narrative and materials address the review criteria →	<ul style="list-style-type: none">• Different review criteria for each individual grant• Different total scores/weights of review categories

The Application Process

How to navigate **starting** and **completing** your application via Submittable

Starting an Application:

- Create Submittable account
- Use an email you check
- **Organizations:**
Consider a “grants” email for your entity
- Verify email address

Completing an Application:

- Read whole prompt, directions
- Make sure you answer the question
- If unsure, reach out to the Grants Team or Program Area
- Submit early; late applications cannot be accepted

Tracking Expenses, Income/In-Kind

Keep track of **expenses, income, and in-kind contributions** as the project unfolds

Expenses

- Record in **budget spreadsheet**
- Keep all **receipts***
- Refer to grant **guidelines, policies** for **allowable expenses**
- **Balance** with income

Income

- Record in **budget spreadsheet**
- Account for **all income**
- Include **requested grant funds**
- **Balance** with expenses

In-Kind

- Record in **budget spreadsheet**
- [Calculate volunteer hours value](#)
- Keep **volunteer hours log**
- Check required **ratio****

*In the Final Report, receipts for grant-funded expenses must be incurred and paid **during the grant cycle**

Common Issues

- Not reading guidelines/general policies
- Not following prompt or directions
- Not monitoring your Submittable messages
 - Consider adding Submittable domain to “safe senders” list
- Not responding to Submittable messages or staff calls
- Not requesting panelist feedback

Understanding Compliance and Final Reports

Preparing for your **final report** and staying **in compliance**

After you are awarded:

- Monitor Submittable messages
- Make sure Vendor account is up-to-date
- Submit change request form if needed
- Be aware of grant cycle close date

Understand Final Reporting requirements:

- Read, save, review Award Packet
- Thank-you letters, proof of acknowledgment
- Be aware of Final Report due date
