Shedra Rakestraw reported that the Calico Ramp plan will be signed off on in approximately one week. Legacy Trail, Segment 1 plan is open for Public Comment from April 14 thru May 9, 2022. Segments II, III and IV will be completing NEPA in the next few months. Suggestions have been submitted to NDOT regarding the Hwy 159 and Hwy 160 expansion. There will be a graffiti clean-up in the Ash Creek Springs area on May 1<sup>st</sup>.

Ranger Mike Siler reported that the BLM has successfully captured and have in custody two known South American gang members for the recent burglaries in the Red Rock parking lots. There was one head-on collision with a motorcyclist illegally riding on BLM land resulting in Flight For Life evacuation. BLM Rangers are fully staffed with 16 Rangers on duty.

Jayson Dagher from Clark County Administrative services was present in place of Meggan Holzer.
