A cover/transmittal sheet shall accompany the plans, with a detailed description of the revisions and the revisions shall be highlighted on the plans Changes post approval require a Minor Deviation application. Changes that cannot be accommodated through a Minor Deviation shall require a new Administrative Design Review or Design Review. Must include a letter summarizing changes to approved plans. Plans must clearly identify the area being revised.
