Per Title 30, Clark County Code Section 30.32.110, the County has excavation restrictions on some roadways which have been paved or resurfaced. The excavation restrictions are for the 5-year period following completed construction on the roadways.

Notifications were sent to utility companies and/or property owners of record prior to construction, unless otherwise noted.
