## Elec., Plumb. & Mech. Permit & Plan Review Fees Schedule – Contract Price Method Building Permit Guide

### Part I. General Information

The following Electrical, Plumbing & Mechanical Permit & Plan Review Fees Schedule – Contract Price Method Guide has been prepared utilizing Table 3-A of the Clark County Building Administrative Code (22.02.400). It is to be utilized to:

- I. Determine electrical, plumbing and mechanical permit and plan review fees associated with “contract price” for the specific specialty scope of work being performed on commercial property as authorized under Section 22.02.345 (G) (1), (2) and (3) of the Clark County Building Administrative Code.

**NOTE:** The contract price for the specific specialty scope of work being covered shall be used to determine the permit and plan review fees.

It should be noted that this method of determining sub-permit and plan review fees based on contract price is an optional choice available to contractors. Although very similar in nature, actual permit fees may vary slightly from the “percentage of building permit fee” method of determining fees. (See Electrical, Plumbing & Mechanical Permit & Plan Review Fees Schedule – Percentage of Building Permit Fee Method Guide).

**NOTE:** A copy of a signed (executed) contract may be required to verify contract price.

### Part II. Example Calculations of Electrical, Plumbing & Mechanical Permit & Plan Review Fees Utilizing Contract Price Method

**NOTE:** Actual calculations for project valuations less than \$100,000 are provided in the attached fees schedule (pages 6 - 9). The following example can be utilized to determine fees for project valuations exceeding \$100,000.

**EXAMPLE TOTAL PROJECT VALUATION: \$753,000**

**STEP 1:** Locate \$700,000 in the “CONTRACT PRICE” column in the fees schedule.

**STEP 2:** Find the corresponding amount from the “PERMIT FEE” column – \$2,297.40.

**STEP 3: Multiply:**

(Represents additional \$53,000 above \$700,000)  
(Cost factor per thousand based on contract price)  
\$ 155.29

**STEP 4: Add the amounts determined in steps 2 & 3 above:**  
\$ 2,297.40  
+ 155.29  
\$ 2,452.69 (Permit Fee)

**STEP 5: If sub-permit is associated with a building permit, determine plan review fee by multiplying permit fee by 25%:**

\$ 2,452.69	(Permit Fee)
X .25	(Plan Review Fee is 25% of Permit Fee)
\$ 613.17	(Plan Review Fee – rounded off)

**STEP 6: If sub-permit is a stand-alone permit, determine plan review fee by multiplying permit fee by 35%:**

\$ 2,452.69	(Permit Fee)
X .35	(Plan Review Fee is 35% of Permit Fee)
\$ 858.44	(Plan Review Fee – rounded off)

**STEP 7: Total electrical, plumbing or mechanical fees due:  
If associated with building permit:**

\$ 2,452.69	(Permit Fee)
+ 613.17	(25% Plan Review fee)
\$ 3,065.86	(Total Fees)

**If stand-alone permit:**

\$ 2,452.69	(Permit Fee)
+ 858.44	(35% Plan Review Fee)
\$ 3,311.13	(Total fees)
