# v. <u>Special Assignments</u>

<u>Legislation</u> – Adleen Stidhum

Adleen gave an update on two bills that passed legislation effective January 1, 2020. (1) SB 207 – Effective January 1, 2020:

- SB338: All Nevada agencies are required to ensure apprenticeships are sought out for public projects on both vertical and horizontal in Clark County which includes all contractors and sub-contractors. All statutes have been updated to ensure compliance such as Pre-Bids and open forums. These statues are noted and quantified in 338.101165.
- SB399: Nevada Helping Small Business Grow was spearheaded by Representative Dina Neal in 2015, piloted through the College of Southern Nevada and came to fruition with full approval in 2019. CSN will continue to oversee the program and its funding. RBDAC, which consist of nineteen government agencies, will co-share the requirements of the bill. Business owners will engage CSN who will introduce them to programs available, and reporting will be via data generation. Mr. Kevin Rayford is the manager of this program. Adleen will charge the Speakers Bureau Chair, Darby Johnson, to invite Mr. Rayford as guest speaker at the BDAC meeting. The guidelines for the bill are in the front-end of the documents for construction, but is not required for architects or engineers to report.
