

# VOTING AND REGISTRATION IN CLARK COUNTY, NV

## Mail/Absentee Ballots and In-Person Voting

**Voting Options:** You have a variety of voting options in Clark County. If you are concerned about being around too many people, you may vote by mail. If you would rather vote in person using a voting machine, you may do so at any early voting site or Election Day vote center of your choice. To help prevent the spread of Covid-19, we encourage you to mail or drop off your ballot rather than vote in-person. Please note the 2021 Boulder City Municipal Elections will be all mail ballot elections. All voters registered in Boulder City will receive a mail ballot whether or not they requested one. Boulder City will also have convenient in-person voting options.

**Mail/Absentee Ballot Voting:** Delivery of mail/absentee ballots begins no later than 20 days before Election Day for in-state voters and no later than 40-45 days before Election Day for out-of-state voters. A listing of mail/absentee ballot drop-off sites will be in your mail/absentee ballot packet, in your sample ballot, and online at [www.ClarkCountyNV.gov/vote](http://www.ClarkCountyNV.gov/vote). **Mail Ballot Postmark and Receiving Deadlines:** Voted mail ballots sent through the Post Office must be: (1) Mailed in the postage-paid return envelope provided specifically for you, which you must also sign (*do not put your ballot in another voter's return envelope*); (2) Postmarked on or before Election Day; and (3) Received by the Election Department on or before the seventh day after Election Day.

**In-Person Voting Using Voting Machines:** You may cast your ballot on a voting machine at any Clark County early voting site or Election Day vote center of your choice, no matter where you live or what your precinct is. If you have your mail ballot with you, you must surrender it at the voting site. If you do not have it with you, you must sign an affirmation that you are not voting twice in the same election. An early voting schedule and listing of Election Day vote centers will be in your mail/absentee ballot packet, in your sample ballot, and online at [www.ClarkCountyNV.gov/vote](http://www.ClarkCountyNV.gov/vote).

## Ex-Felons

**Ex-Felons Have the Right to Immediately Register to Vote:** People with felony convictions in Nevada or in any other state who are not incarcerated may immediately register to vote as long as they follow the standard procedures for doing so and satisfy Nevada's standard voter registration requirements (U.S. citizen, at least 18 years of age by the next Election Day, resident in Clark County for at least 30 days, and resident in their precinct for at least 10 days). No special procedures or paperwork are required. This also applies to people whose voter registration had been previously canceled because of a felony conviction and to those who are currently on probation or parole.

## Deadlines for Registration and Updates, Plus Related Information

**Deadlines for New Registration and Updates of Existing Registration:** The last day to register to vote or update existing voter registration, either by mail or in person, for the current election is the **fourth Tuesday before Election Day** (known as the standard close of registration). You may still register to vote or update your existing registration after the standard close of registration as indicated below. - **ONLINE ONLY Voter Registration or Updates**
  - Online Only Dates: Starts the fourth Wednesday before Election Day and ends two days before early voting begins, only at [www.registertovotenv.gov](http://www.registertovotenv.gov).
  - ID: You will need current and valid **Nevada DMV ID** (a Nevada Department of Motor Vehicles driver's license, Nevada DMV State Identification card, or Nevada DMV "Interim Document") to register or log-in to make updates. It might sometimes be required to vote.
  - Voting: You should be eligible to vote a *regular ballot* in the current election.
- **SAME-DAY UPDATES of Existing Voter Registration (Online or In-Person):**
  - Online Dates: Starts one day before early voting begins and ends the second to last day of early voting, only at [www.registertovotenv.gov](http://www.registertovotenv.gov).
  - In-Person Dates: During early voting or on Election Day at any voting site you choose.
  - ID: You will need current and valid **Nevada DMV ID** to log-in online to make updates, but it is not required for in-person updates. It might sometimes be required to vote.
  - Voting: For the current election, you may only vote a *provisional ballot* and only in person. See "Same-Day Updates of Existing Registration..." below for details.
- **SAME-DAY VOTER REGISTRATION (Online or In-Person):**
  - Online Dates: Starts one day before early voting begins and ends the second to last day of early voting, only at [www.registertovotenv.gov](http://www.registertovotenv.gov).
  - In-Person Dates: During early voting or on Election Day at any voting site you choose.
  - ID: You will need current and valid **Nevada DMV ID** to register online or in-person. It will also be required to vote.
  - Voting: For the current election, you may only vote a *provisional ballot* and only in person. See the next page for details.

## Same-Day Updates of Existing Registration, Online or In-Person (Details)

**How It Works:** During the time period for same-day updates, you may immediately update your existing voter registration (address, party, etc.) either online on the Secretary of State's website at [www.registertovotenv.gov](http://www.registertovotenv.gov) or in person at any Clark County early voting site or Election Day vote center. You may then vote a full provisional ballot with all contests, candidates, and questions that are on a regular ballot at any Clark County early voting site or Election Day vote center. Your provisional ballot will be counted only after verification of your registration data and that you did not cast more than one ballot in the same election.

## **Same-Day Voter Registration, Online or In-Person (Details)**

**How It Works:** During the time period for same-day voter registration, you may register to vote in the current election either online at [www.registertovotenv.gov](http://www.registertovotenv.gov) or in-person at any Clark County early voting site or Election Day vote center. You must satisfy Nevada's standard registration requirements (U.S. citizen, at least 18 years of age by the next Election Day, resident in Clark County for at least 30 days, and resident in your precinct for at least 10 days) and you must have a current and valid unexpired **Nevada DMV ID**, as specified below.

### **Requirements:**

- Whether you register to vote online ([www.registertovotenv.gov](http://www.registertovotenv.gov)) or in person at any Clark County early voting site or Election Day vote center, when you check-in to vote you must show a required **Nevada DMV ID**, as listed below (*ID from another State is NEVER acceptable*). It should list your name and current residential address where you actually live, and that information must match your voter registration:
  - A current and valid unexpired Nevada Department of Motor Vehicles Driver's License; or
  - A current and valid unexpired Nevada State ID Card, issued by the DMV; or
  - A current and valid unexpired temporary Nevada DMV "Interim Document."
- **IF** the address is not current on the above required **Nevada DMV ID** (does not match your registration or is not where you actually live), you also **must ADDITIONALLY provide** together with the required **Nevada DMV ID** proof of your current residence that includes your name and address, such as:
  - A military identification card
  - A bank or credit union statement
  - A paycheck
  - An income tax return
  - A property tax statement
  - A motor vehicle registration
  - A utility bill (electric, gas, oil, water, sewer, septic, phone, cell phone, cable)
  - A mortgage statement, or residential rental or lease agreement
  - Any other document issued by a governmental agency

**Attention: The above is to supplement required **Nevada DMV ID**, NOT substitute for it.**

- You must immediately vote at the early voting site or Election Day vote center where you register or check-in (no other site).
- You will vote a full provisional ballot with all contests, candidates, and questions that are on a regular ballot. Your provisional ballot will be counted only after verification that: (1) You were qualified to register to vote and cast a ballot in the current election; (2) You did not cast multiple ballots in the same election; and (3) **IF** applicable, confirmation you provided acceptable additional proof of residency to supplement your **Nevada DMV ID**.
