

REQUEST FOR EMERGENCY BALLOT

NRS 293.316

If you are suddenly hospitalized, become seriously ill or are called away from home **AFTER** the deadline for requesting a mail ballot (14th day before the election); or you are unable to go to the polls on Election Day because of an illness or disability resulting in confinement in a hospital, sanatorium, dwelling or nursing home, you may request an Emergency Ballot.

WHEN TO REQUEST AN EMERGENCY BALLOT:

The period to request an Emergency Ballot begins the second Wednesday prior to Election Day and ends at 5:00 p.m. on Election Day. An Emergency Ballot must be requested in writing from the Election Department located at 965 Trade Dr. Suite A – North Las Vegas. Faxed ballot requests are acceptable. No request may be made by another person on behalf of a registered voter even with Power of Attorney.

YOUR WRITTEN REQUEST MUST INCLUDE:

1. Your name as it appears on your Voter Registration Application
2. Your Clark County residence address
3. Your signature
4. The name and address of the person you have designated to obtain, deliver, and return your voted ballot.
5. The designee's signature
6. A brief statement of your illness or disability or facts sufficient to establish you were called away from home
7. A statement that only you (the registered voter requesting the ballot) will mark and sign the ballot or that you will give permission for your designee to mark and sign your ballot on your behalf.

If the person designated to obtain your ballot will mark and sign the ballot on your behalf, that person must indicate next to his/her signature that the ballot has been marked and signed on your behalf.

WHEN TO RETURN THE BALLOT

Your voted ballot must be returned to the County Election Department not later than 7:00 p.m. on Election Day located at:
