The work for the above referenced project has been completed. Please see the attached for all project related information.

The purpose of the above referenced project was:

Recent fires in and around the Muddy River have brought into focus the need to do fire prevention on the newly acquired Muddy River Reserve property (Henrie). To accomplish this purpose seventeen hundred feet of fire break fifteen feet wide was created along the northern property border.

The major accomplishment or findings of this project include:

The risk of fire on the property and fire spreading to neighboring property was greatly reduced by the creation of the fire break. In the creation of the fire break a great deal of tamarisk was removed and treated to prevent re-growth.
