The work for the above referenced project has been completed. Please see the attached for all project related information.

**The purpose of the above referenced project was:**

The purpose of this project is to provide restoration services for the enhancement of habitat for native riparian species of concern for the Multiple Species Habitat Conservation Plan (MSHCP).

**The major accomplishment or findings of this project include:**

The major accomplishment was an area on our property was cleared of undesirable vegetation and replanted with natives. Desirable natives, ash, mesquite, and antelope bush, were left in place. The Exotic Plant Management Team collected and stored cuttings of native plants in their Song Dog Nursery. They transported the grown plants and planted in the project area. Cut-stump treatment was conducted on tamarisk growing along the steep slopes and the cut material was dispersed around the site for vertical mulch. Revegetation included a variety of techniques, deep pot planting, willow pole cuttings, and traditional planting method. Tree shelters were installed on each transplant (except the grass) to protect from herbivory and to concentrate watering. The site is monitored for weed establishment.
