**The purpose of the above referenced project was:**

The purpose of this project is to create a story map that is focused on OHV recreation in Clark County. A story map uses maps along with narrative text, images and multimedia products to disseminate information.

**The major accomplishment or findings of this project include:**

A story map focused on the Boulder City Conservation Easement (BCCE) was produced for this project. It is expected that the story map will function as a "go to" source of BCCE information for the Clark County OHV community. For instance, the story map includes up-to-date information on road designation across the BCCE (e.g. trails open to OHV use), highlights popular OHV trailheads and amenities provided, highlights some points of interest along the trails (i.e., historic sites, petroglyphs, etc.), and provides the "rules" for using OHVs in the BCCE. In addition, the story map will be used by the DCP to disseminate environmental messaging to the Clark County OHV community.

If successful, the story map may serve as a prototype for future efforts to disseminate information about other areas of interest in Clark County.
