The purpose of the above referenced project was:

This study was to collect data on local nesting pairs of peregrine falcons on Lake Mead National Recreation Area (LMNRA) as described in the national Post De-listing Monitoring Plan for this species, which was recovered from Endangered status under the Endangered Species Act in 1999. The majority of known peregrine falcons nesting locations in Nevada are located in the Lake Mead National Recreation Area.

The major accomplishment or findings of this project include:

- A habitat suitability model and associated maps that were used to target surveys for undocumented peregrine territories in LMNRA
- Results were delivered as final project data and final report.
