Each justice of the peace shall charge and collect the following fees:	
<b>On the commencement of any action or proceedings in the justice court, other than in actions commenced pursuant to Chapter 73 of NRS, to be paid by the party commencing the action: (General Civil Cases)</b>	
If the sum claimed does not exceed \$2,500.00	\$74.00**
If the sum claimed equals or exceeds \$2,500.00 but does not exceed \$5,000.00	\$124.00**
If the sum claimed equals or exceeds \$5,000.00 but does not exceed \$10,000.00	\$199.00**
If the sum claimed equals or exceeds \$10,000.00 but does not exceed \$15,000.00	\$274.00**
Unlawful Detainer (formal Civil)	\$246.00*

If the sum claimed equals or exceeds \$5,000.00 but does not exceed \$7,500.00	\$146.00*
If the sum claimed equals or exceeds \$7,500.00 but does not exceed \$10,000.00	\$196.00*

Returned Check Fee (non-sufficient funds)	\$35.00
<b>Cash, Debit/Credit (Visa, Discover or MasterCard), Personal Check (excluding tenant answer fees, cash bails, bonds, deposits), Money Order, Cashiers Check Accepted (<i>made payable to Henderson Justice Court</i>). Payee's with personal checks returned for non-sufficient funds will be charged a \$35 fee and will no longer be permitted to submit personal checks as a form of payment.</b>	
<i>Henderson Justice Court accepts debit and credit cards bearing the Visa, Discover or Mastercard logo for all payments that are due the court, to include traffic citations, civil fees, criminal fines and bail. Payments cannot be accepted over the phone. A customer may not exceed \$3,000.00 in Credit Card Transactions within a three-day calendar period. Payee must show a photo ID that matches the name on the credit card before it will be accepted for payment. Photo ID is not required for ATM and Debit Card Transactions.</i>
