# **EXECUTIVE SUMMARY**

The 1 October Memorial Committee's effort to engage the community resulted in 5,199 people participating in an 8-question online survey fielded from August 2-15, 2021. Respondents typically discovered the survey through newsletters/intranet sites/email blasts including those from their workplaces, by text message, or by Facebook.

- Geographically, 86.6% of respondents were from Nevada, 12.6% were based domestically, but outside Nevada, and 0.8% of respondents from international locations.
- Just over half of respondents (54.5%) identified as a community member. Over one in seven (14.7%) identified as survivors, nearly one in ten (10.4%) identified as a first responder or community responder, 4.2% lost a family member or a friend, and 5.6% were family/friends of survivors. Nearly one in ten (9.7%) indicated having been in the immediate vicinity at the time of the shooting.

# **Key findings:**

- 1. There is strong agreement with all proposed elements of an education component by a majority of respondents. Combined somewhat/strongly agree ratings reveal that:
  - a. 91.8% support the inclusion of stories of community heroism and support
    - i. Less among immediate families of the 58 (82.0%)
  - b. 84.3% agreed with support for mental health
    - i. Less among first responders (71.7%)
  - c. 83.8% support including survivor stories
    - i. More among those experiencing mental health impact (96.0%)
  - d. 82.4% agreed with biographies of victims
    - i. More among immediate families of the 58 (92.3%)
  - e. 75.5% agreed that education should include lessons learned by first responders and the hospitality industry
- 2. Regarding specific suggestions for an artistic feature, combined somewhat/strongly agree/support ratings show support for all ideas mentioned:
  - a. 92.7% agreed with symbolic representation of the 58 victims
  - b. 72.1% agreed with including images provided by those impacted
    - i. More among those experiencing mental health impact (86.9%)
  - c. 53.1% agreed with references to country music
    - i. More among survivors with/without physical injury (91.9% & 90.2%), and those with mental health impact (91.7%)
  - d. 90.5% support an alternative to a water feature, if water is not used
    - i. More among those experiencing mental health impact (100%)
- 3. Ranked options for mementos demonstrate:
  - a. A slight preference for the first option of having a pre-determined memento to be personalized and incorporated into the design (39.3% ranked first)
    - i. More among those with mental health impact (50.0%)
  - b. A secondary preference for the second option of special occasion/pre-approved mementos (44.4% ranked second)

- i. More among those with mental health impact (65.0%) and families/friends of first responders (56.1%)
- c. The least preferred option is that of having no mementos allowed (60.7% ranked last)
  - i. More among those with mental health impact (75.0%)
- 4. When asked about support for using technology in various elements of the memorial, large minorities among respondents were supportive:
  - a. 49.1% support use with the education component
    - i. More among community responders (59.0%) and those who otherwise knew someone directly impacted (67.7%)
  - b. 44.7% support use with an artistic feature
    - i. More among community responders (58.2%) and those who otherwise knew someone directly impacted (58.3%)
  - c. 39.7% support use as an option for digital mementos
    - i. More among community responders (50.6%), families and friends of survivors (51.7%), and those who otherwise knew someone directly impacted (52.8%)
  - d. 22.8% felt that technology would not be preferable for this memorial

## INTRODUCTION

The 1 October Memorial Advisory Committee is a seven-member group of citizens appointed to develop ideas and recommendations, based on community input, for a permanent 1 October Memorial that will remember those who perished in the events of 1 October 2017, honor the survivors, and the many heroes who inspired the nation with their bravery, and to celebrate the resiliency and compassion of our community. To accomplish its mission, the Committee conducted a second survey of the community and those impacted by the 1 October shooting, using Cannon Survey Center at the University of Nevada, Las Vegas as the partner for survey development, data collection, and preparation of the results. The survey instrument was developed collaboratively with the Committee using the results of a prior survey and focus groups as a guide, and was approved by the Committee during the public meeting on July 28, 2021.

# DATA COLLECTION


The survey was administered using the Qualtrics online survey platform from August 2-15, 2021; 6,306 accessed the survey link and 5,199 respondents were retained, having answered one or more question (roughly 5,000 answered most or all questions). The survey was available in Spanish, utilized by 0.3% of respondents (n=13). Recruitment of survey respondents was done primarily through a planned media effort by Clark County Public Communications and the 1 October Memorial Committee, which included a dedicated website, an advertising and marketing campaign, news media outreach, outreach to survivor groups and other groups of local and government employees impacted, and word of mouth (snowball sampling).

## SURVEY RESULTS


#### **EDUCATION**

Survey respondents were advised that 73% of prior survey respondents felt that education was very or extremely important, and that focus groups refined this finding by indicating that the memorial should avoid political topics and personal details about the perpetrator. They were then prompted to indicate their level of agreement with a series of suggested education topics.


The vast majority of survey respondents (91.8%) either strongly agreed (77.5%) or somewhat agreed (14.3%) that education should include stories of community heroism and support. Immediate families of the 58 were somewhat less likely to indicate as such (82.0%).




A clear majority (82.4%) strongly or somewhat agreed that biographies of victims should be included (61.6% and 20.8%, respectively). Immediate families of the 58 were somewhat more likely to indicate as such (92.3%)




Similarly, 83.8% strongly or somewhat agreed that survivor stories should be included (59.8% and 24.0%, respectively). Those indicating having a mental health impact from the event were more likely to indicate as such (96.0%).



Another 84.3% strongly (69.5%) or somewhat agreed (14.8%) that education should include support for mental health. First responders were somewhat less likely to indicate as such (71.7%)




Roughly three in four respondents (75.5%) agreed or strongly agreed (52.7 and 22.8%, respectively) that education should also include lessons learned by first responders and the hospitality industry.





# ARTISTIC FEATURE

Survey participants were then advised that 60% of previous survey respondents indicated that an artistic feature would be very or extremely important, and that focus groups had provided some ideas for the feature. When asked to rate agreement with these features, 53.1% somewhat or strongly agreed with references to country music, 92.7% somewhat or strongly agreed with symbolic representation of the 58 victims, and 72.1% somewhat or strongly agreed with including images provided by those impacted.


Immediate families of the 58 were more likely to agree with references to country music (76.3% somewhat or strongly agreed), as were survivors with injuries (91.9%), survivors without (90.2%), and those who reported a mental health impact (91.7%). Those who reported a mental health impact were more likely to agree with use of images from those impacted (86.9%).







The survey then explained that while some suggest that a water feature would be ideal, water conservation concerns may be an issue, and asked about support for an alternative feature. The vast majority (90.5%) indicated that they would either strongly or somewhat support an alternative feature to achieve tranquility in the design (71.8% and 18.7%, respectively). Those reporting mental health impact were somewhat more likely to agree (100%).




## **MEMENTOS**

The survey went on to explain that the Committee learned of some problems associated with unlimited mementos at memorials, and offered potential solutions for survey respondents to rank. The first option indicated a specific pre-determined memento that would be incorporated into the design. This option

was ranked first by 39.3% of respondents, second by 40.2% of respondents, and third by 20.5%. The second option indicated mementos only on special occasions and with caretaker approval, which was ranked first by 36.9%, second by 44.4%, and third by 18.8% of respondents. The final option indicated that mementos should not be allowed; this was ranked first by 23.9% of respondents, second by 15.4%, and third by a 60.7% majority.


Survivors with physical injury and in general were more likely to rank the final option as the least favored option at 71.8% and 71.9%, respectively. Those reporting mental health impact were more likely to rank the first option as most favored (50.0%), the second option as second most favored (65.0%), and the third option as least favored (75.0%). Families and friends of first responders were somewhat more likely to indicate the second option as second most favored (56.1%).



# TECHNOLOGY

Respondents were then asked to indicate which, if any, of the memorial components should include technology in some form. Nearly half (49.1%) indicated support for technology used in conjunction with the education component(s), 44.7% support the use of technology for the artistic feature, and 39.7% support the use of technology for digital mementos. Meanwhile, over one in five (22.8%) indicated that technology would not be preferable for this memorial.

Extended family and close friends of the 58 were more likely to support the use of technology for digital mementos (50.6%). Community responders were somewhat more likely to support the use of technology with education (59.0%), an artistic feature (58.2%), and for mementos (50.6%). Family and friends of survivors were also somewhat more likely to support the use of technology for mementos (51.7%). Those who otherwise know/knew someone directly impacted were also more likely to support the use of technology with education (67.7%), an artistic feature (58.3%), and for mementos (52.8%).



# RESPONDENTS


To better understand the perspectives of survey respondents, respondents were asked to identify the ways in which they were impacted by the 1 October event. Slightly more than half of survey respondents (54.5%) identified as a community member or were identified as such given their comments under "otherwise impacted."<sup>1</sup> Given that roughly one in five respondents originally selected "otherwise impacted," the responses were reviewed for recoding into new and existing categories.<sup>2</sup>

Over one in ten respondents (11.8%) identified as survivors, 4.2% lost a family member or close friend, and 5.6% are family/friends of survivors. First responders made up 4.6%,<sup>3</sup> and their family/friends 0.9%. Nearly one in ten (9.7%) indicated having been in the immediate vicinity at the time of the shooting. Among community members and otherwise impacted respondents, there were many comments that referenced survivors' guilt either directly or indirectly, using terms such as "I should/could have been there," or "I had tickets but didn't go."





When asked how they found out about the survey, respondents most frequently indicated that a newsletter/email blast/intranet site (30.2%), text message (23.6%), or Facebook (18.2%) had informed them of the survey. Results for "other" responses often referenced the Las Vegas Resiliency Center, various workplaces/companies, the Nextdoor app, and others which can be found in Appendix C.



To assess the reach of the survey, respondents were asked to provide zip codes. The vast majority of respondents are from Nevada (86.6%), 12.6% are domestic other than Nevada, and 0.8% are international. Results for individual zip codes are provided in Appendix D.

I AM A BORN AND RAISED RESIDENT OF LAS VEGAS, AND CARE GREATLY ABOUT THIS CITY. I HAVE A FRIEND WHO ALMOST WENT, MY FATHER DROVE PAST THE SITE MINUTES AFTER THE SHOOTING WHILE RETURNING HOME FROM WORK, AND I HAVE ACQUAINTANCES WHO WERE INJURED BUT SURVIVED THE ATTACK. MOST OF THE WORLD HAS FORGOTTEN THIS TRAGEDY AND MOVED ON, I WILL NEVER FORGET WATCHING THE NEWS THAT NIGHT, CALLING ALL MY FRIENDS, SEEING PEOPLE DROP TO THE FLOOR ON THE NEWS' REPLAY. I AM STILL SCARED AT OTHER EVENTS IN THE CITY, AVOID THE STRIP ON NEW YEAR'S AND OTHER HOLIDAYS. FIREWORKS ARE A REMINDER TO ME OF WHAT THOSE PEOPLE ON OCTOBER 1ST HEARD. THEY THOUGHT THE GUNSHOTS WERE FIREWORKS. I WILL NEVER FORGET THAT EITHER. I CAN'T IMAGINE HOW HORRIBLE AND TRAUMATIC THESE MEMORIES ARE FOR THOSE WHO WERE ACTUALLY THERE, OR LOST PEOPLE BECAUSE OF IT, OR NEARLY DID. MY HEART IS WITH EACH ONE OF THEM.

I AM A DEALER IN A NEARBY CASINO. ALTHOUGH I WAS WORKING AT THE TIME OF THE EVENT, I WAS AMONG THE VERY FEW EMPLOYEES WILLING TO COME IN ON THE GRAVEYARD SHIFT TO TAKE INVENTORY AND MEET WITH CUSTOMERS THAT RAN FROM THE TABLES, LEAVING MONEY AND PERSONAL BELONGINGS. WHEN I WALKED INTO THE EMPTY CASINO, ALL OF THE GAMING TABLES STILL HAD HANDS DEALT, DICE THROWN, ROULETTE NUMBERS MARKED AND PERSONAL ITEMS ON THE TABLES. THE BETS WERE STILL THERE AS IF A THOUSAND PEOPLE SUDDENLY VANISHED. I SPENT THE NIGHT AT WORK THINKING ABOUT ALL OF THE PEOPLE WHO HAD BEEN KILLED. IN THE BLINK OF AN EYE, A FLASH OF A MUZZLE, 58 PEOPLE VANISHED FROM LIFE.

I AM A MENTAL HEALTH PROFESSIONAL.

I AM A TEACHER WHO HAD STUDENTS IMPACTED PERSONALLY AND SAT WITH THEM THE NEXT DAY AS THEY ALL WAITED FOR UPDATES

I AM A UNLV STUDENT

I AM AN EMPLOYEE AT A LAS VEGAS BRANDED HOTEL- NOT MGM BUT COMPETITOR.

I AM CONNECTED WITH SEVERAL OTHER SURVIVORS

I AM CURRENTLY IN EMPLOYMENT AFFECTED BY IT

I AM IMPACTED IN THAT I AM EXTREMELY SAD ABD DISAPPOINTED IN THE FACT THAT WE HAVE NOT CHANGED THE LAWS RE: ASSAULT WEAPONS.. USE THE FUNDS \$ TO CHANGE THE LAW ... ANYTHING ELSE IS A WASTE OF MONEY.. BECAUSE THIS IS GOING TO CONTINUE...

I AM LAW ENFORCEMENT.

I ATTENDED EVERY YEAR OF RT.91 EXCEPT THIS ONE.

I ATTENDED ROUTE 91 BUT WAS NOT THERE AT THE TIME OF THE SHOOTING.

I ATTENDED THE FIRST TWO DAYS BUT WAS NOT THERE ON THE DAY OF THE SHOOTING

I BECAME A FIRST RESPONDER AFTER OCT 1 AND IT HAS IMPACTED OUR RESPONSE TO CRITICAL INCIDENTS I BECAME FRIEND WITH A SURVIVOR WHO WAS SHOT AT THE EVENT BECAUSE SHE WAS RIGHT IN FRONT OF ME, WE STAYED TOGETHER DURING THE SHOOTING. WE RECONNECTED AFTER SHE GOT OUT OF THE HOSPITAL AND HAVE REMAINED IN CONTACT SINCE

I CONDUCTED A STUDY THAT COLLATED AROUND 200 NARRATIVE RESPONSES ABOUT THE EXPERIENCES PEOPLE HAD AT OR AROUND 1 OCTOBER AND FOLLOWED THEM UP 1.5, 3, 6, AND 12 MONTHS LATER IN TERMS OF THEIR MENTAL HEALTH, WELL-BEING, LIFE CHANGES, PERCEIVED SUPPORT AND CRITICISM, AND PERSONALITY. I CONSTANTLY GET TO SEE "VEGAS STRONG" STICKERS NEXT TO "COME AND TAKE IT" STICKERS PERFECTLY ENCAPSULATING HOW DIFFICULT THE ROAD FORWARD WILL BE AND WHY ANY ATTEMPT TO DISCUSS THIS TRAGEDY WITHOUT GETTING POLITICAL IS NAIVE AND ONLY WORKS TO ENSURE IT CONTINUES TO HAPPEN

I COULD'VE EASILY BEEN THERE AS I'M A HUGE COUNTRY FAN.

I DID NOT KNOW ANYONE BUT I WAS SO EMOTIONALLY MOVED IT BRINGS ME TO TEARS THINKING ABOUT IT. I DON'T BELIEVE I HAVE EVER BEEN SO SHOCKED AS WHEN A TELEVISION PROGRAM WAS INTERRUPTED WITH THE NEWS OF "AS ACTIVE SHOOTER ON THE STRIP" AND WATCHING THE HORROR UNFOLD. AFTERWARDS, I DON'T BELIEVE I HAVE EVER BEEN MORE PROUD THAT SO MANY STRANGERS PULLED TOGETHER. I DROVE BY JUST BEFORE THINKING HOW HAPPY ALL MY FRIENDS WERE TO BE THERE. THEN THE SIRENS STARTED WHEN I GOT HOME FROM WORK. I STILL FEEL SO SAD EVERY TIME I DRIVE BY THE SITE.

I FELT VERY HELPLESS AND SADDENED BY THIS DEVASTING MOMENT SO CLOSE TO HOME.

I HAD A FAMILY MEMBER IN CALIFORNIA CALL ME ASKING IF I WAS AT THE CONCERT, AND IF I WAS OK. AT THE TIME, I LIVED 6 MILES WEST OF THE LOCATION. IT CONCERNED MY FAMILY IN CALIFORNIA.

I HAD A GUN SUDDENLY PULLED ON ME THE FOLLOWING DAY OF THE SHOOTING AND WAS TRAUMATIZED AND IMMEDIATELY THOUGHT OF THE MASS SHOOTING

I HAD A TICKET AND CAME HOME INSTEAD BECAUSE I WAS PREGNANT AND COULDN'T STAND ANY LONGER.

I HAD BEEN IN VEGAS 2 YEARS AND THOUGHT IT WAS AWFUL. SEEING THE COMMUNITY COME TOGETHER AND HEAL BROUGHT ME MORE THAN I EVER THOUGHT IT COULD HAVE.

I HAD FAMILY IN THE AREA THAT NIGHT, BUT THEY WEREN'T KILLED OR INJURED

I HAD FAMILY IN THE IMMEDIATE VICINITY. HUSBAND FIRST RESPONDER

I HAD FAMILY MEMBERS IN THE IMMEDIATE VICINITY

I HAD FRIENDS WHO HAD BEEN ATTENDING THE EVENT. ONE FELT UNWELL THE DAY OF THE SHOOTING, SO ALL THREE DECIDED NOT TO GO THAT EVENING. I KEPT THINKING THEY COULD HAVE DIED THAT NIGHT.

I HAD PLANNED TO GO BUT DID NOT. WAS DEVASTATED TO LEARN OF THIS TRAGEDY.

I HAD TICKETS FOR THE MUSIC FESTIVAL. I LIVED IN VEGAS.

I HAD WANTED TO ATTEND BUT DUE TO THE LOSS OF MY FATHER PRIOR I FORGOT ABOUT IT. I COULD HAVE BEEN THERE. PLUS THIS HAPPENED ESSENTIALLY IN MY BACKYARD OF LAS VEGAS

I HAD WORKED AT THE SITE ALL WEEK AND WAS GIVEN SUNDAY OFF. AFTER THE EVENT I ORGANIZED MY OFFICE CREW TO DELIVER WATER AND FOOD TO THE PEOPLE AT THOMAS AND MACK AND HAD PORT OF SUBS DELIVERED TO THE FIRST RESPONDERS AT SUNRISE HOSPITAL AND UMC

I HAVE BEEN SCARED TO GO INTO BIG EVENTS UNTIL RECENTLY. FIREWORKS ALWAYS SCARE ME NOW. THEY SOUND A LOT LIKE GUN FIRE.

I HAVE CO-WORKERS AND FRIENDS WHO WERE AT THE EVENT. I HAD TO BE A SUPPORT FOR THEM AFTERWARDS AND EVEN TODAY, I SOMETIMES, HAVE TO PROVIDE HELP WHEN THE MENTAL HEALTH ISSUES BECOME TOO MUCH TO BEAR ALONE.

I HAVE FAMILY IN LAS VEGAS AND FELT AN IMMEDIATE CONNECTION

I HAVE FAMILY IN LAS VEGAS, WHO WERE IMPACTED EMOTIONALLY BY THE EVENT.

I HAVE FIRST RESPONDER FAMILY/FRIENDS WHO WERE THERE AS IT WAS HAPPENING AND WHO ALSO RESPONDED TO THE INCIDENT. I OPEN MY CLASSES UP TO THE SURVIVORS. PLUS, I HAVE SURVIVORS TAKE MY COURSES.

I HAVE FRIENDS THAT WERE WORKING DOWN THE STREET THAT NIGHT.

I HAVE GONE TO THAT FESTIVAL SINCE ITS INCEPTION BUT HAD BACK SURGERY AND COULDN'T ATTEND. IF I ATTENDED IN A WHEELCHAIR, I ONLY IMAGINE THAT I WOULD HAVE BEEN SHOT DUE TO INABILITY TO FLEE QUICKLY. I ALSO HAD FRIENDS THAT ATTENDED THAT YEAR.

I HAVE MANY FRIENDS IN LAS VEGAS WHO WORK IN THE MEDICAL FIELD, AND WOULD LIKE THEIR SERVICE ACKNOWLEDGED

I HEARD THE GUN SHOTS FROM MY HOME. WE LOST OUR SON 7 MONTH'S PRIOR, IT CAUSED MY ANXIETY TO SKY ROCKET. VEGAS IS OUR HOME, IT WAS LIKE WE WERE ALL INVADED. NOT LIKE THE SURVIVOR'S OR THEIR FAMILIES BUT I KNOW MANY THAT HOLD THEIR CHILDREN EVEN CLOSER

I JUST REALLY FELT SO SAD WHEN THE EVENTS HAPPENED BECAUSE I LOVE THE LAS VEGAS AREA BECAUSE I GOT MARRIED THERE IN 2004

I LISTENED TO THE WHOLE ENTIRE THING ON MY POLICE SCANNER. LISTENING TO THE POLICE OFFICERS PANICKING AND A FEW WERE CRYING WHICH THE WHOLE THING MADE ME CRY LISTENING AS IT WAS HAPPENING.

I LIVE ABOUT 3 MILES FROM THE SITE, HEARD THE SIRENS ALL NIGHT, AND KNOW SEVERAL PEOPLE WHO WERE PERSONALLY IMPACTED BY THIS HORRIBLE EVENT.

I LIVE CLOSE TO THE SITE AND OPENED MY DOOR TO PROVIDE A SAFE SPACE FOR PEOPLE ESCAPING THE AREA. I LIVE NEARBY AND WAS EMOTIONALLY IMPACTED BY THE FACT THAT THE EVENT OCCURRED SO CLOSE TO HOME.

I LIVE ON WESTCLIFF DRIVE. THERE IS AN AMAZING MEMORIAL TO THE VICTIMS OF 10CTOBER THERE DIRECTLY ACROSS FROM THE 7-11 ON WESTCLIFF. I FEEL STRONGLY THAT MEMORIAL SHOULD SOMEHOW, SOMEWAY BE INCLUDED BECAUSE IT HELPED ME TO HEAL FROM THE HORRORS OF THAT EVENT.

I LOST MY MOTHER THE SAME WEEKEND, SO I FELT THE PAIN OF THE 58 FAMILIES IN AN IMMEDIATE AND UNFORGETTABLE WAY

I LOVE GOING TO CONCERT GATHERINGS. ALL THE PEOPLE AT MUSIC VENUES ARE MY BROTHERS AND SISTERS. I SHOULD HAVE BEEN THERE I WAS GOING BUT THEN UNEXPLAINABLE REASONS KEPT ME AWAY. TWO OF MY COWORKERS DIED THAT NIGHT. MANDALAY BAY WAS MY SAFE HANGOUT SPOT. NOT ANYMORE MY FRIENDS HAVE BEEN TERRORIZED. THE HORROR STORIES THAT OCCURRED IN THE HOTEL THAT NIGHT WILL ALWAYS STAY WITHIN OUR SOULS. I REMIND ALL WHAT THE TATTOO ON MY LEFT FOREARM STANDS FOR AS I CASHIER. RIP 100117 AND REPRESENTATION OF THE DELICATE PURPLE BUTTERFLY. AT 4:30 AM I VISITED THE 58 CROSSES. IN THE EARLY MORNING HOURS I WAS NOT ALONE. A GENTLE MAN MOURNING THE LOSS OF A LOVED ONE WHILE I PAY MY RESPECT TO ALL THE SOULS LOST IN THE TERROR ACT ON THE STRIP. I REMEMBER LEAVING PORTABLE LIGHTERS SO THEIR CANDLES WOULD STAY LIT. THEN HANDING OUT 58 RED ROSES TO THOSE WHO DESIRED TO RECEIVE ONE. DURING THE YEAR FOLLOWING I WOULD COME ACROSS NUMEROUS PEOPLE WHO WOULD HAVE THEIR OWN STORIES TO SHARE. THE ONE THAT STICKS IN MY MIND IS WHEN I WAS SITTING AT THE BAR WATCHING VGK PLAYOFFS AND THE WOMAN NEXT TO ME NOTICED MY TATTOO AND BROKE DOWN. SORROW WAS ALL OVER FACE. YOU SEE SHE WAS A NURSE AND SHE WAS AT THE CONCERT THAT NIGHT BUT SHE WAS SO TERRIFIED THAT SHE FROZE. I GAVE HER LONG HUG AND WHISPERED IN HER EAR THAT IT WAS GOING TO BE OKAY AND WE SOBBED TOGETHER. THE NIGHT OF THE FIRST ANNIVERSARY I PHOTOGRAPHED ORBS HOVERING OVER THE SIGHT. SO MANY SOULS LOST IN A DIFFERENT REALM. I APPRECIATE ALL THE WORK BEING DONE FOR THIS MEMORIAL AND I PRAY THAT SOMEWHERE AMONGST IT ALL THAT THERE BE BUTTERFLIES REPRESENTING EACH SOUL LOST.

I LOVE LAS VEGAS AND THE SURROUNDING TOWNS. I FELT LIKE MY HOME HAD BEEN ATTACKED FOR NO REASON. IT WAS TRAGIC. WHEN I RETURNED TO VEGAS FOR CHRISTMAS, I WAS MOVED TO TEARS BY THE CROSSES STATIONED WHERE THE TRAGEDY HAD OCCURRED. I WAS IMPACTED THE SAME WAY BY 9/11 BECAUSE I HAD WORKED IN THE WALL STREET AREA.

I MET 2 SURVIVORS IN NEWPORT BEACH 11-3-21 WHILE THERE TO SEE AN EXPERT IN FIELD OF BREAST IMPLANTS EN BLOC EXPLANT WHICH DIRECTLY AFFECTED MY BODY WITH AUTOIMMUNE ISSUES. I COULD NOT DONATE MY PERFECT GIFT AS A UNIVERSAL DONOR OF O NEGATIVE BLOOD. WE SHARED, THEY TALKED, I LISTENED, WE WEPT, HUGGED! THE GAL HAD FRIENDS WITH IMPLANTS WHO WERE SICK AND WOULD SHARE THE INFO! WE WERE FRAGILE FROM THE EVENT, THEY SURVIVED BUT HAD NOT KNOWN IF ANYONE AND ALL IN THEIR GROUP WERE SAFE THE WHOLE EVENING! YET HERE THEY WERE, BACK TO WORK IN HOSPITALITY SERVICE JOBS! IT WAS A BLESSED HEALING MOMENT! OUR SON WAS WORKING HIS UBER/LYFT SHIFT AT MCCARREN AND CALLED ME VERY CONCERNED, "TOO MANY POLICE/RESCUE VEHICLES AND DIDN'T WANT TO BRING HIS PASSENGERS INTO DANGER!" IT TOOK HIM AN HOUR AND HALF TO GET HOME WHAT NORMALLY WAS 15-20 MINUTE DRIVE. HE WAS SAFE AND HAD BEEN WISE TO LEAVE AREA. I WAS SO IMPRESSED WITH OUR VEGAS FIRST RESPONDERS AND HOW STEVE SISOLAC RAISED THE ENORMOUS AMOUNT OF FUNDS! SO PROUD OF LAS VEGAS AND HORRIFIED SOMEONE COULD CONJURE SUCH A NIGHTMARE!

I NEVER THOUGHT THAT COULD HAPPEN IN LAS. I CRIED A LOT

I PROVIDED EXTENSIVE TRAUMA COUNSELING AFTER THE EVENT. MORE THAN I THINK I HAVE EVER DONE IN MY CAREER BEFORE OR SINCE.

I SOLD MY TICKET LAST MINUTE BUT I WAS SUPPOSED TO ATTEND

I THOUGHT MY DAUGHTER WAS THERE TO PHOTOGRAPH THE EVENT FOR HER EMPLOYER & WAS UNABLE TO LOCATE HER UNTIL JUST BEFORE LEAVING TO IDENTIFY BODIES @ THE CONVENTION CENTER-I WAS STRONGLY AFFECTED AS A RESIDENT/COMMUNITY MEMBER.

I USED KOVAL EVERY DAY FOR MY COMMUTE TO WORK. IT MAKES ME SAD/ANGRY THAT THIS HAPPENED. I SAY A PRAYER EVERY TIME I PASS IT. JUST LIKE BEING AT 911 THIS IS SOMETHINGS I WILL NEVER FORGET AND SHOULD ALWAYS BE MEMORIALIZED.

I USED TO LIVE IN OASIS APARTMENTS RIGHT BEHIND THE FESTIVAL GROUNDS. I LIVED THERE FOR 5 YEARS. I RAISED MY FIRST SON THERE AND SPENT MANY NIGHT SITTING OUTSIDE LISTENING TO ALL THE MUSIC ALTHOUGH I WASN'T THERE THAT NIGHT I FEEL SUCH A STRONG CONNECTION TO THE AREA AND A SENSE OF HAVING TO DO SOMETHING TO PROTECT AND REMEMBER THE IMPACT IT HAD ON SO MANY DIFFERENT PEOPLE.

I WAS A FIRST RESPONDER AT A LOCAL CASINO DURING THE EVENT.

I WAS A FIRST RESPONDER BUT NOT ON DUTY

I WAS A FIRST RESPONDER CONCERT GOER

I WAS A HOSPITALITY WORKER ON THE STRIP WHO WAS EVACUATED FROM MY WORK PLACE THAT EVENING.

I WAS A JOURNALIST COVERING THE EVENT

I WAS A MANDALAY BAY EMPLOYEE AND WAS WORKING THAT NIGHT.

I WAS A REPORTER

I WAS A STUDENT MENTAL HEALTH PROFESSIONAL WHO LIVED BY AND ATTENDED UNLV. THE EVENT FELT EXTREMELY CLOSE TO ME AND I HAVE MINOR TRAUMA MEMORIES OF THE EVENT INCLUDING NOT KNOWING IF THE SHOOTER WAS AT LARGE AND HEARING THE SIRENS FOR HOURS, NOT KNOWING IF MY FRIENDS WHO WERE ATTENDING WERE SAFE, ETC. AFTER THE EVENT I WAS IMPACTED AS A RESIDENT AND A STUDENT. I WAS ALSO A FIRST RESPONDER VOLUNTEERING TO PROVIDE FREE MENTAL HEALTH SERVICES AT OUR STUDENT CLINIC TO OTHER VICTIMS AND COMMUNITY MEMBERS. I PASSED BY THE BROKEN WINDOWS EVERY DAY. AND THE MORNING AFTER YOU COULD FEEL THEIR DEATHS IN THE AIR AROUND YOU. IT WAS HIGHLY EMOTIONAL AND PAINFUL AND STILL BRINGS TEARS AS I WRITE THIS NOW. THERE WERE MORE THAN 58 VICTIMS THAT DAY ONLY 58 THAT WERE KILLED. PLEASE RECOGNIZE THOSE WOUNDED BY BULLETS L, TRAUMA AND LOSS. THOSE NUMBERS ARE IN THE HUNDREDS AND THOUSANDS.

I WAS ASKED TO WORK AT THAT EVENT BUT DECLINED BECAUSE IT GOING TO GET OVER TO LATE AT NIGHT. SO WE WENT TO THE HOCKEY GAME INSTEAD. WE DROVE RIGHT PAST THE SITE MINUTES BEFORE THE SHOOTING STARTED.

I WAS AT THE ALAIN DUCASSE RESTAURANT AT THE DELANO, OVERLOOKING THE CONCERT AND WAS LOCKED DOWN FOR SEVERAL HOURS IN THE RESTAURANT ON THAT AWFUL NIGHT

I WAS AT THE CONCERT AND RAN BACK IN AFTER GETTING MY FAMILY OUT AND CARRIED MANY VICTIMS OUT DURING THE SHOOTING, TWO THAT PASSED IN MY ARMS, ONE THAT PASSED AT THE HOSPITAL, RACHEL PARKER AND ANOTHER THAT I HELPED CARRY OUT THAT DID NOT SURVIVE. MANY OF THOSE THAT I CARRIED OUT SURVIVED AND I AM BLESSED TO BE ALIVE, PROUD THAT I WAS THERE TO HELP AND LIVE EACH DAY WITH LOVE IN MY HEART FOR THOSE WE LOST THAT NIGHT. #LOVEWINS #COUNTRYSTRONG. THANK YOU FOR ALL YOU DO AND PROVIDE TO US THAT WERE THERE AND GIVE US RESOURCES TO HELP EACH PERSON AFFECTED THAT TERRIBLE NIGHT. I REALIZE YOU PROBABLY DON'T HEAR IT VERY OFTEN, BUT REALLY, THANK YOU. -SURVIVOR, TODD BLYLEVEN

I WAS AT THE EVENT BUT I LEFT EARLY (BEFORE THE SHOOTING). SEVERAL OF MY FRIENDS WERE THERE BUT THANKFULLY ALL SURVIVED.

I WAS AT THE MAKESHIFT MEMORIAL AT THE LAS VEGAS SIGN

I WAS DRIVING FOR UBER AND DROPPED 2 YOUNG LADIES OFF FOR THE MUSIC FESTIVAL. WE CHATTED ABOUT IT. I HOPE THEY ARE OKAY.

I WAS EMOTIONALLY OVERWHELMED THAT THIS HAPPENED IN THE US

I WAS IMPACTED BECAUSE I LIVE HERE AND STILL CAN'T BELIEVE THAT SOMETHING SO SINISTER LIKE THIS COULD HAPPEN HERE. I THINK ABOUT THE TRAGIC INCIDENT AND WONDER HOW IT WILL BE PREVENTED IN THE FUTURE. I DON'T ATTEND OUTSIDE GATHERINGS ANYMORE.

I WAS IMPACTED BY THE LOW LEVEL OF SECURITY AT THE CASINOS AND VENUES IN THIS CITY, CAUSING THIS UNFORTUNATE INCIDENT.

I WAS IN SHOCK THAT IT ACTUALLY HAPPENED IN MY HOMETOWN! I HAVE LOST ALL OF MY FAMILY HERE EXCEPT MY SISTER BY HEALTH PROBLEMS SO TO HAVE AN ACTUAL HOMETOWN TERRORISTS ATTACK DURING A CONCERT I WAS IN SHOCK!

I WAS INVOLVED IN PRODUCING A MUSIC FESTIVAL THE FOLLOWING WEEKEND THAT ESSENTIALLY GOT NO ATTENDANCE DUE TO THE PUBLIC'S FEAR OF BEING IS SUCH SPACES

I WAS LIVING AND WORKING IN MANHATTAN WHEN THE TOWERS CAME DOWN. I IMMEDIATELY GOT A FLASHBACK WHEN THIS TOOK PLACE HERE IN VEGAS. ALL THOSE SAME FEELINGS OF ANGER, OF HELPLESSNESS, OF PEOPLE BRING THERE FOR ONE ANOTHER CAME TO MIND.

I WAS LIVING IN CA AND MY KIDS WERE HERE, WORKING ON THE STRIP. THE INFO COMING IN FROM VEGAS WAS SPOTTY AND I WAS WORRIED ABOUT MY KIDS, WHO I COULD NOT REACH.

I WAS LOCKED IN MANDALAY BAY ALL NIGHT. I WAS AT MICHAEL JACKSON ONE WHEN THE SHOOTING STARTED. I DIDN'T GET HOME UNTIL 9AM

I WAS LOCKED IN THE REDNECK RIVIERA WITH JOHN RICH AND HIS BAND. TRIED TO HELP SURVIVORS INCLUDING FRIENDS WHO ARE SURVIVORS.

I WAS NOT A COMMUNITY MEMBER AT THAT BUT HAD AND HAVE FAMILY IN THE COMMUNITY. WE NEED SIMPLE HONOUR AND RESPECT NOT A SHOW NOT A ME ME ME BUT FAITH OVER FEAR

I WAS ON DUTY BUT IN ANOTHER PART OF THE CITY. I THEN WAS ON THE OVERHEAD TEAM FOR THE ASSISTANCE CENTER WORKING WITH LOCAL RESPONDERS, ARC, AND FBI

I WAS ON THE LAST PLANE OUT AS THE CARNAGE OCCURRED. I VIEWED IT ON SNAPCHAT AS IT HAPPENED AND THE WOMAN BESIDE ME SAW. WORD SPREAD FAST AND NEARLY EVERYONE ON THE PLANE WAS SCREAMING AND CRYING, MOST CAME FROM THAT CONCERT. I WAS AT NETAPP INSIGHTS CONFERENCE IN MANDALAY EARLIER IN THE DAY

I WAS ON THE OTHER SIDE OF AIRPORT DRIVING HOME TO UNLV AREA AND SAW/STOPPED FOR ALL THE EMERGENCY VEHICLE TRAFFIC SPEEDING WEST

I WAS ONLINE LISTENING IN REAL TIME AS WELL AS VARIOUS CALLS FROM THE SCENE. TO THIS DAY, I CAN STILL HEAR THE RAPID FIRE OF GUN SHOTS THAT NIGHT. IF I HEAR/WATCH A GUN BATTLE (YOUTUBE) IT TAKES ME BACK. I CANNOT STAND HEARING ANY GUN SHOTS OR FIREWORKS. ALL OF WHICH I REALLY HAD NO ISSUE WITH PRIOR TO OCTOBER 1ST.

I WAS OVERWHELMED, MOVED, AND HORRIFIED. AS A NATIVE LAS VEGAN I WAS ALSO ASHAMED. I WORK FOR UNLV AND WAS EXTREMELY PROUD OF THE LEVEL OF ASSISTANCE OFFERED BY STUDENTS AND EMPLOYEES. I WAS RECOVERING FROM SURGERY HOME ALONE AND CRIED CONSTANTLY A FORM OF PTSD. IT WAS SO SAD FOR ALL THE PEOPLE WHO LIVE IN LAS VEGAS

I WAS RETURNING FROM MY SISTER'S FUNERAL THE DAY THE SHOOTING HAPPENED.

I WAS SHOCKED AND HORRIFIED THERE HAS BEEN NO MENTION OF GUN CONTROL RELATED TO THE INCIDENT. AN ABSENCE OF EVEN A DISCUSSION OF GUN CONTROL IS AN INSULT TO EVERY VICTIM, THEIR FAMILY, FRIENDS AND THE COMMUNITY.

I WAS SO SO SAD. I CRIED FOR DAYS. WAS NOT THERE. I COULD NOT BELIEVE IT HAPPENED IN LAS VEGAS.

I WAS SUPPOSED TO ATTEND. ALL MY FRIENDS WERE THERE AND MY BOYFRIEND

I WAS SUPPOSED TO WORK THAT NIGHT

I WAS TERRIFIED, HORRIFIED, AND HEARTBROKEN WATCHING THIS PLAY OUT ON THE MEDIA. I CRIED AND CRIED THAT THIS COULD HAPPEN IN OUR CITY. I WAS MENTALLY DRAINED BY THIS HORRIFIC ACT OF VIOLENCE TO PEOPLE HE DIDN'T EVEN KNOW.

I WAS THE WEDDING OFFICIANT AT THE FOUR SEASONS. THE ENTIRE GROUP OF GUESTS CAME FROM LONDON, ENGLAND. FOLLOWING DINNER AND DANCING, ETC. THE HOTEL IMMEDIATELY MOVED EVERYONE TO THE STAIR WELL. EVENTUALLY THEY WERE ALL MOVED INTO A ROOM, GIVEN A BLANKET, ETC. THE BRIDE SLEPT IN HER WEDDING GOWN. THE IMPACT ON EVERYONE WAS SIGNIFICANT. AS THE FORMER HEAD OF THE NEVADA BROADCASTERS ASSOCIATION, I RECEIVED CALLS FROM ACROSS THE COUNTRY AND ACTUALLY IN THE MIDDLE OF THE NIGHT, SPOKE LIVE ON AIR IN SEVERAL CITIES. WHEN I WATCHED TV AND THEY EVENTUALLY SHOWED THE GUEST ROOM WHERE THE SHOTS WERE FIRED, I WAS SADDENED. THE BRIDE'S ROOM WAS EITHER JUST ABOVE, OR JUST BELOW. IT WAS THE SAME ROOM. AS A 30 YEAR RESIDENT OF LAS VEGAS I AM SO PLEASED AND STRONGLY SUPPORT ALL THAT YOU ARE DOING. THE NIGHT OF THE WEDDING, I HAD THREE FRIENDS HOST MY SUNDAY NIGHT RADIO SHOW. A YEAR LATER, MY GUEST HOST THANKED ME FOR SAVING HER LIFE. HOW SO? EVERY YEAR MY HUSBAND AND I WAS THERE. EVERY YEAR WE STOOD RIGHT IN FRONT OF THE STAGE. WE CHANGED OUR TICKETS TO GO THE NIGHT BEFORE, SO THAT WE COULD HOST THE RADIO SHOW. HAD WE BEEN AT THE CONCERT ON SUNDAY NIGHT, WE WOULD HAVE BEEN STANDING IN FRONT..... BOB FISHER, FORMER 23 YEAR CEO OF THE NEVADA BROADCASTERS ASSOCIATION.

I WAS THERE AN HOUR B4 THE...SHOOTING..I DIDN'T HAVE A TICKET AND IT WAS SOLD OUT SO I LEFT BEFORE THE SHOOTING....GRATEFUL I COULDN'T STAY

I WAS WORKING AT SUNRISE HOSPITAL AND HELPED MANY OF THE VICTIMS & FAMILIES WITH SOCIAL SERVICES.

I WAS WORKING AT THE AIRPORT DURING THE TIME OF THE EVENT AND SPOUSE WAS AN DOA ESCORT WHO HELP ASSISTED ON AIRFIELD.

I WAS WORKING AT THE AIRPORT THE EVENING OF THE INCIDENT

I WAS WORKING AT THE STRIP AT THAT TIME AND REALLY SHOCKED ME HOW WE WERE NOT PREPARED FOR SOMETHING LIKE THIS

I WAS WORKING SECURITY DISPATCH AND HAD A PATROL OFFICER IN THE AREA. I ALSO HAD MY PTSD FROM A DIFFERENT EVENT SEND ME INTO A PANIC ATTACK WHILE AT WORK.

I WAS WORKING THAT NIGHT ON THE STRIP AS A SECURITY OFFICER IN ONE OF THE MAJOR CASINOS/ HOTELS. I HELPED COUNTLESS INJURED SURVIVORS AND EVEN GOT OFF WORK AND HELPED PEOPLE GET BACK TO THEIR HOTELS WHO WERE FRIGHTENED OR HAD LONG WALKS AFTER WORKING MY GRAVEYARD SHIFT

I WAS WORKING VERY CLOSE TO THE ECHOES

I WATCHED IT ON TV

I WATCHED THE 2017 VGK HOME OPENER AND WAS DEEPLY IMPACTED IN A GOOD WAY.

I WITNESSED IT ON A LOCAL NEWS FEED

I WORK AT MANDALAY BAY

I WORK AT UMC SAW THE COURAGE OF ALL STAFF MEMBERS WHO SUPPORTED VICTIMS AND FAMILIES

I WORK FOR ARIA RESORT I'M NEAR PROXIMITY THE FALL OUT HAD GREAT EFFECTS. HEART BREAKING.

I WORK FOR FIRST RESPONDERS WHO WERE THERE AND HAD TO DEAL WITH THIS TRAGEDY.

I WORK FOR THE CITY AND WE ARE ACTIVE IN THE MEMORIAL WORK.

I WORK ON THE STRIP IN A COUNTRY BAR FOR 12 YRS.

I WORKED AT CLARK COUNTY FIRE DEPT WITH RESPONDERS

I WORKED AT MANDALAY BAR AND WAS A RESPONDER

I WORKED AT MANDALAY BAY AND HAD A CONVENTION GOING ON DURING THE TIME OF THIS TRAGEDY. I WAS IMPACTED IMMENSELY BY THIS.

I WORKED AT PIZZA HUT AT THE TIME AND UMC WAS IN MY DELIVERY ZONE. I HONESTLY THINK MY BRAIN HAS BLOCKED OUT THE MAJORITY OF THE DAY OF THE 2ND. PEOPLE WERE MAKING COUNTLESS ORDERS TO THE HOSPITAL.

I WORKED AT THE FAC AND VSRC; VICARIOUS TRAUMA

I WORKED AT THE MUSEUM WHERE THE CROSSES WE BROUGHT IN.

I WORKED AT THE MUSEUM TO CATALOG ALL ITEMS LEFT AT THE SIGHTS AROUND TOWN.

I WORKED CLOSE BY THE NIGHT BEFORE

I WORKED FOR MGM CORPORATE ENTERTAINMENT AT THE TIME OF THE ATTACK AND HAD MANY COLLEAGUES AT THE EVENT.

I WORKED I THE HOTEL THE MORNING OF OCT. 2ND TO HELP GUIDE OUT OF TOWN VISITORS TO CRISIS CENTERS AND KEEP OTHER VISITORS CALM. I HELPED COLLEAGUES AT MANDALAY BAY GATHER PERSONAL BELONGINGS OF GUESTS

I WORKED IN A CASINO OFF THE STRIP THAT TOOK IN PEOPLE WHO HAD BEEN DISPLACED OR WERE AT THE EVENT.

I WORKED WITH MOMS DEMAND ACTION FOR GUN SENSE AND WAS DEVASTATED THAT OUR WORK ALWAYS SEEMED TO BE IN VAIN

I'M A HUMAN! I FELT PAIN OF INNOCENT CONCERT PARTICIPANTS WHO WERE HAVING A FUN/GOOD TIME DISRUPTED BY A MANIAC UNHAPPY WITH SELF & LIFE. ALSO, A LESSON LEARNED FOR HOTEL STAFF TO CHECK FOR THE UNUSUAL WITHOUT PREJUDICING CERTAIN PEOPLE. ALSO, WE NEED EXTENSIVE GUN REFORM TO PREVENT MASS MURDERS.

I'VE WONDERED IF SOMETHING LIKE THIS EVENT, OR SIMILAR, COULD HAPPEN IN THE STATE, WHERE I LIVE ...

IN LOCATION MOMENTS BEFORE INCIDENT AND FELL I COULD HAVE LOST MY LIFE. ALSO MY BIRTHDATE

IT AFFECTED HOW I PERCEIVED SECURITY AND SAFETY IN LAS VEGAS

IT CAUSED ME SUCH GRIEF. THE VICTIMS LISTENING TO MUSIC ARE MURDERED IS OUTRAGEOUS AND HEARTBREAKING TO HEAR..

IT MAKES ME FEEL UNSETTLED THAT THIS COULD HAPPEN AGAIN

IT WAS A HORRIBLE THING THAT HAPPENED AND VERY SAD

IT WAS A VERY TRAGIC EVENT AND IT REALLY AFFECTED ME EVEN THOUGH I'M IN MISSISSIPPI. I WORK AT A MGM CASINO

IT WAS AND HORRIFIC THING TO WITNESS AND I KNEW PEOPLE WHO LOST FRIENDS AND FAMILY MEMBERS. IT WAS ONE OF THE WORST THINGS I'VE EVER SCENE

IT WAS JUST AND WILL ALWAYS BE UNFATHOMABLE

IT WAS SHOCKING TO THE CITY!

I WAS AT THE EVENT ALL DAY/NIGHT; HOWEVER, LEFT 30 MINUTES PRIOR TO THE SHOOTING. JUST AN OBSERVER AT THAT TIME FROM ANOTHER STATE. VERY SAD FOR EVERYONE IMPACTED. THE NRA IS EVIL AND WE NEED GUN REFORM NOW.

JUST HEARING ABOUT THIS TRAGEDY MADE AN IMPACT ON ME

JUST LEFT THE CONVENTION AREA SHORTLY BEFORE THE SHOOTINGS I WAS CHECKING OUR EQUIPMENT LOCKING UP

JUST WATCHING IT ON TV WAS HORRIFIC. I CRIED SO MANY TEARS AND GO DEPRESSED JUST HEARING AND WATCHING IT. EVERY OCTOBER 1 IT EFFECTS MY PERSONAL EMOTIONS AND I CRY FOR WHAT HAPPENED THAT DAY. JUST A NORMAL LAS VEGAS CITIZEN HANGING OUT AT HOME LOVING LAS VEGAS AND BAM EVERYONES' LIVES CHANGED BUT WE ALL CAME TOGETHER IN THE MOST UNIFIED WAY. THANK YOU TO LAS VEGAS AND THE ENTIRE WORLD IT EFFECTED FOR YOUR SUPPORT.

LED SURVIVOR SUPPORT GROUPS AT STONEY'S FOR 2 YEARS FOLLOWING TRAGEDY

LIVING OUTSIDE OF THE CITY LIMITS, I WAS NOT PHYSICALLY IMPACTED. BUT BECAUSE OF IT BEING IN MY STATE, IT WAS ALL OVER THE NEWS AND SOCIAL MEDIA SO MUCH SO THAT IT REALLY AFFECTED ME EMOTIONALLY AND MENTALLY. I ALSO HAD A FEW FRIENDS WHO WERE THERE BUT THANKFULLY WERE NOT INJURED.

LOCAL GOVT EMPLOYEE

LOCKED IN AT THE MGM DAYCARE WITH THE CHILDREN WHILE SCARED PARENTS/SURVIVORS HID AND TEXTED FROM OUTSIDE.

LOOKING FOR THE "TRUTH"?

LOSS AMONG PEOPLE I KNOW

MADE A LAST MINUTE DECISION NOT TO ATTEND.

MADE ME HATE PEOPLE EVEN MORE

MAKING A DOCUMENTARY ABOUT THE FIRST RESPONDERS TO THE EVENT.

MANDALAY BAY EMPLOYEE

MAY THIS MEMORIAL INCLUDE WISDOM QUOTES THAT INSPIRE OTHERS....

MEDIA MEMBER AND MEMBER OF COMMUNITY

MEMBER OF THE MEDIA AT THAT TIME, SUPERVISING THOSE COVERING THE EVENT OVER FOLLOWING DAYS/WEEKS

MENTAL HEALTH THERAPIST

MY BEST FRIEND IS A SURVIVOR AND I DEALT WITH THE SCARS AND RECOVERY PROCESS FOR SUPPORT MY BOYFRIEND AND SEVERAL CO-WORKERS WERE LOCKED DOWN IN A COUPLE OF HOTEL IN CLOSE PROXIMITY. THEY WERE REALLY EFFECTED BY THIS SENSELESS ACT OF VIOLENCE. I MYSELF, WAS FRIGHTENED I MIGHT NOT SEE ANY OF THEM AGAIN.

MY BROTHER HAD FINISHED HIS SHIFT AS LONGTIME DEALER AT MANDALAY BAY. HIS WIFE WAS AT WORK AS A 21DEALER ON THE FLOOR AT THE TIME OF THE SHOOTINGS...AND HAD TO FLEE THE SCENE WITH GO WORKERS. SHE AND MY BROTHER RARELY MENTION THIS TRAUMA.

MY BROTHER WAS WORKING SECURITY AT THE FOUNDATION ROOM AT MANDALAY BAY THAT NIGHT. IT WAS A SCARY TIME FOR OUR FAMILY AND HE WAS MENTALLY EFFECTED BY SOME OF THE THINGS THAT OCCURRED THAT NIGHT.

MY BROTHER WORKS AT THE MANDALAY BAY AND WAS LOCKED DOWN IN THE BUILDING FOR HOURS.

MY CHILD WAS IN THE HOTEL AT THE TIME OF THE SHOOTING

MY DAD SAVED A WOMAN WHO SURVIVED. AND HELPED PEOPLE ESCAPE.

MY DAUGHTER ALMOST ATTENDED THAT CONCERT.

MY DAUGHTER AND BOYFRIEND INTENDED TO ATTEND. WE WERE UNAWARE THEIR LAND HAD CHANGED. WE WERE OUT OF TOWN AND FRANTICALLY TRYING TO FIND OUT IF THEY WERE ALRIGHT.

MY DAUGHTER HAD TO CANCEL HER PLANS TO ATTEND THIS EVENT

MY DAUGHTER WAS AT EVENT NEXT DOOR. HID IN A BATHROOM

MY DAUGHTER WAS IN THE IMMEDIATE VICINITY AND HAD A VERY HARD TIME DEALING WITH & WORKING THROUGH HER FEELINGS! CONCERT ATTENDEES JUMPED IN HER CAR BEGGING HER TO GET THEM OUT OF THERE - SHE TOOK TWO ATTENDEES HOME!

MY DAUGHTER WAS THERE THE NIGHT BEFORE THE SHOOTING.

MY DAUGHTER WAS WORKING AS SECURITY DURING THIS TRAGIC ORDEAL AND WAS NOT ABLE TO LEAVE THE STRIP UNTIL THE NEXT DAY WITHOUT CONTACT OR NOTHING THIS WAS VERY STRESSFUL DURING THAT TIME BECAUSE I DID NOT KNOW WHAT HAD HAPPENED TO MY DAUGHTER BUT THANKS TO GOD ALMIGHTY SHE SURVIVED

MY DAUGHTER WAS WORKING AT MANDALAY BAY THAT NIGHT, SHE WAS IMPACTED AND THEREFORE I WAS. THESE EVENTS IMPACT A LOT OF PEOPLE WHO MAY NOT HAVE EVEN BEEN IN THE VICINITY.

MY DAUGHTER WORKS ACROSS THE STREET AT THE FOUR SEASONS, PART OF THE MANDALAY BAY COMPLEX. SHE HAD FRIENDS AT THE CONCERT, HAD HER HOTEL CLOSED FOR A PERIOD OF TIME, AND THEN HAD TO WALK THROUGH FEDERAL CRIME SCENE TO GET TO WORK.

MY FAMILY MEMBER WAS TRAPPED WORKED ROOM SERVICE AT MANDALAY BAY

MY FAMILY WORKS ON THE STRIP & WAS JUST A FEW BLOCKS AWAY. WE ALL HELPED OUT AFTERWARDS... MY FATHER WAS KILLED BY AN ACT OF TERRORISM... I RELATE AND HAVE AN UNDERSTANDING OF THIS GRIEF SPACE FOR 36 YEARS OF MY LIFE..

MY FRIEND ALMOST DIED

MY FRIEND COMMITTED SUICIDE THE SAME DAY (UNRELATED)

MY GIRL FRIEND AND I WERE SUPPOSED TO ATTEND THIS CONCERT FOR MY BIRTHDAY BUT WE WERE UNABLE TO GO DUE TO WORK SCHEDULES WE WERE BOTH THANKFUL AND ALSO VERY DISTURBED THAT THOSE WHO ATTENDED WERE PUT INTO A SITUATION THAT ENDED SO BADLY WHEN IT WAS SUPPOSED TO BE A GREAT EXPERIENCE

MY GRANDSON HAD BEEN AT T-MOBILE FOR HOCKEY, DRIVE BY AREA ON WAY HOME LESS THAN 30 MINUTES BEFORE IT HAPPENED. SCARED US ALL. ALSO, MY DAUGHTER WOULD HAVE BEEN THERE BUT TURNED DOWN TICKETS!!

MY HUSBAND AND I ARE AIRLINE EMPLOYEES AND CONCERT GOERS. WE PARKED AT TERMINAL 1 ECONOMY LOT TWO DAYS AFTER THE RAMPAGE AND WERE CHILLED TO SEE THE SHOT OUT WINDOWS OF THE HOTEL. GOD BLESS ALL INVOLVED. THANK YOU FOR WHAT YOU'RE DOING FOR THIS MEMORIAL.

MY HUSBAND AND I ARE FORMER MANDALAY BAY EMPLOYEES AND I HAVE NOT BEEN TO A STRIP HOTEL SINCE THAT HAPPENED.

MY HUSBAND WORKS AT MANDALAY BAY EVENTS AND WAS VERY HESITANT TO RETURN TO WORK AFTER THE INCIDENT

MY OPINION ON GUN CONTROL MEASURES WAS CHANGED...TO SUPPORT STRONGER MEASURES.

MY PLACE OF EMPLOYMENT WAS IMPACTED

MY ROOMMATE WAS THERE WITH MY TICKET AND I WAS SUPPOSED TO MEET HER BUT COULDN'T GET AHOLD OF HER SO I STAYED HOME INSTEAD.

MY SISTER WAS MURDERED IN THE PAST AND THIS SHOOTING, LIKE ALL OTHER VIOLENT CRIMES, BRINGS THAT ORIGINAL PAIN BACK. MY HEART GOES OUT TO ALL THE VICTIMS AND THEIR FAMILIES BECAUSE I KNOW HOW THEY FEEL.

MY SISTER WAS WORKING ON THE STRIP WHILE THIS TRAGEDY HAPPENED. I WAS ON THE PHONE WITH HER THROUGH THE WHOLE TIME, MY FAMILY AND I WERE SCARED FOR HER SAFETY.

MY SON AND HIS WIFE ATTENDED LIFE IS BEAUTIFUL. THEY LEARNED THAT THE PERPETRATOR WAS SEEN AT ONE OF THE VENUES, PRESUMABLY TO SCOPE IT OUT. THIS HAD A QUITE AN EFFECT ON THEM. HENCE THE FOCUS ON MENTAL HEALTH.

MY SON AND MY YOUNG GRANDCHILDREN LIVE IN LAS VEGAS. MY SON NOW OPEN CARRIES LEGALLY DUE TO THIS CITY/COMMUNITY ATTACK.

MY SON IS METRO AND RESPONDED TO THE SCENE. I AM A NURSING DIRECTOR AT SUNRISE HOSPITAL AND MY SON LET ME KNOW WHAT OCCURRED AND I RESPONDED AT SUNRISE THAT NIGHT. SUNRISE HOSPITAL TOOK

THE HIGHEST NUMBER OF THOSE INJURED MORTALLY OR OTHERWISE THAT NIGHT. FOR MONTHS AFTER, MY STAFF AND WERE AFFECTED BY THE EVENTS OF THAT NIGHT. WE CONTINUE TO HONOR THE VICTIMS AND CELEBRATE THE FIRST RESPONDERS AT SUNRISE HOSPITAL EVERY YEAR.

MY SON WAS IN THE AREA.

MY SON WAS IN THE IMMEDIATE VICINITY

MY STEP DAUGHTER WAS THERE, I WORK AT LVMPD SO MY COWORKERS DAUGHTER WAS SHOT...IT WAS JUST A HORRIFIC EVENT FOR OUR CITY. SO MANY LIVES IMPACTED.

MY TEAM WAS INSTRUMENTAL IN SETTING UP AN EMERGENCY OPERATIONS CENTER AND FAMILY ASSISTANCE CENTER FOR MOST ALL INFORMATION TECHNOLOGY NEEDS AT THE LV CONVENTION CENTER.

MY TEENAGE SON WAS SUPPOSED TO WORK THE EVENT BUT AT THE LAST MINUTE HIS FATHER TOLD HIM HE COULD NOT.

MY WIFE HAD BAD IMAGES AND FEELINGS FOR A LONG TIME AFTER THIS, AS IT HAPPENED IN OUR CITY AND IT MADE HER AFRAID TO EVEN GO OUT

NOT AFFECTED PHYSICALLY OR MENTALLY BY THE EVENT BUT SAD NONETHELESS.

NOT FEELING SAFE OUTDOORS

OCT 1ST IS MY BIRTHDAY.

WATCHING THE NEWS WHEN THE FIRST BREAKING NEWS CAME UP ON TV

WE ARE ALL IMPACTED AS A COMMUNITY. IF YOU HURT ONE OF US, YOU HURT ALL OF US. WE ARE ALL IMPACTED BY GUN VIOLENCE AS IT THREATENS OUR SENSE OF SECURITY AND THE SECURITY OF OUR FAMILY.

WE HAVE A MEMORIAL. WHY IS ANOTHER BEING BUILT?

WE LIVE VERY CLOSE BY SO WE SAW ALL THE CHAOS GOING ON, THE HELICOPTERS, HEARS ALL THE SIRENS, SAW FIRST RESPONDERS RACING TO SITE. MY FAMILY WENT TO HELP PICK UP STRANDED CONCERT GOERS AND GET THEM OUT OF THERE TO SAFETY BECAUSE SO MANY WERE WANDERING AIMLESSLY OR FROZEN IN SHOCK. OUR VERY CLOSE FRIEND WORKED FOR ALLEGIANT AIR AND SPENT THE NIGHT HARBORING PANICKED, WOUNDED CONCERT GOERS WHO HAD ESCAPED INTO THE TARMAC. HE CONTACTED FAMILIES AND DRIVE A COUPLE OF YOUNG GIRLS TO SAFETY. MY DAUGHTER RUNS A LOCAL MUSIC BAR FOR THE LAST 13 YEARS WHERE MANY MANY OF HER REGULAR CUSTOMERS, BELOVED FRIENDS, WERE ANNUAL ROUTE 91 ATTENDEES. THERE WAS DEEP TRAUMA AMONGST ALL CIRCLES WHO WERE TOUCHED BY THIS EVENT. MY DAUGHTER FELT IT, I FELT IT, OUR FRIENDS FELT IT. MY LITTLE BOY USED TO TAKE CLASSES AT APPLE STORE BEFORE COVID SHIT THE CLASSES DOWN AND HIS ABSOLUTE FAVORITE, MOST LOVED TEACHER WAS THERE AT ROUTE 91 AND LEFT FOR DEAD AFTER HER FRIENDS WERE GUNNED DOWN. SHE LIE THERE FROZEN WITH A WOUNDED LEG JUST SOBBING UNTIL A TOTAL STRANGER PULLED HER BEHIND A BAR. ALSO, ONE IF THE THREE NEIGHBORS WE ARE CLOSE WITHIN OUR BUILDING WAS THERE WITH FRIENDS AS SHE WAS A BEVERAGE MANAGER FOR MANDALAY BAY WORKING ON DUTY. SHE WAS SO TRAUMATIZED THAT SHE HAS BECOME A COMPLETE LONER AND CAN BRING HERSELF TO GO ANYWHERE BUT TO WORK AND HOME. EVEN BEFORE COVID SHE WAS ORDERING GROCERIES IN. WE BROUGHT HER FOOD BOXES WHILE SHE WAS OFF WORK FOR A YEAR DUE TO COVID BUT SHE JUST RECENTLY WENT BACK. SHE IS A REALLY NICE LADY, AND IT IS APPARENT HOW MUCH SHE IS STRUGGLING STILL. THIS EVENT CHANGED HER LIFE & SHE WILL NEVER BE THE SAME. I DON'T THINK THE SUPPORT OR COUNSELING WAS AVAILABLE ENOUGH AND THE FACT THAT IT FEEL LIKE THIS WHOLE EVENT HAS JUST KIND OF BEEN SWEPT UNDER THE RUG BY THE MEDIA AND THE STEAMROLLER THAT IS...LIFE, IS RE-TRAUMATIZING PEOPLE EVERY DAY. THE PEOPLE WE KNOW WHO WERE THERE DURING, AND/OR AFTER THE SHOOTINGS HAVE EXPRESSED THAT THEY FEEL LIKE IT'S "INAPPROPRIATE " TO BRING UP OR TO TALK ABOUT, LIKE IT'S A DIRTY SECRET THAT NO ONE REALLY WANTS TO FACE. I THINK PEOPLE INVOLVED HAVE JUST HAD TO STUFF THEIR FEELINGS AND BECOME HARDENED TO IT BECAUSE IT'S NOT REALLY AN ACCEPTABLE SUBJECT IN MOST CIRCLES AND THAT MAKES ME FEEL SO SAD. NOW WITH EVERYTHING ELSE GOING ON IN THE WORLD, IT SEEMS ALL BUT FORGOTTEN. I THINK A MEMORIAL IS ABSOLUTELY NECESSARY AND I DEFINITELY THINK IT NEEDS TO BE AT THE SITE EVEN THOUGH I IMAGINE THE CASINO WANTS TO DISTANCE THEMSELVES FROM ANY ASSOCIATION WITH THE MOTORS OF SUCH A TRAGIC EVENT WHERE THEIR HANDLING OF THE EVENTS AS THEY UNFOLDED WERE PART OF WHAT LED TO IT BECOMING AS DESTRUCTIVE AS IT WAS. OBVIOUSLY HINDSIGHT IS 20/20 AND I DON'T BELIEVE THEY WOULD EVER HAVE THOUGHT SOMETHING LIKE THAT COULD, OR WOULD HAVE HAPPENED...AND THE REALITY THAT WE ALL ARE STUCK DEALING WITH IS THAT WE ARE NEVER REALLY SAFE WHEN OUT IN A PUBLIC SPACE. BUT IT STILL FEELS LIKE THINGS COULD HAVE BEEN DIFFERENT HAD THEY BEEN MORE DILIGENT. I HOPE THIS MEMORIAL IS MADE, AND I HOPE IT IS AS BIG AND BRIGHT AS THE LIGHT AT THE TOP OF THE LUXOR PYRAMID SO THAT IT STANDS AS A MEMORIAL AND REMINDER FOR ALL WHO ENTER THIS TOWN TO SEE...WHETHER BY CAR OR BY AIRPLANE. KNOWING THAT THERE ARE COUNTLESS PEOPLE EVERY DAY WHO ARE EDUCATING THEMSELVES AND THEIR FAMILIES ABOUT THE DIFFICULT EVENTS THAT PRECIPITATED THE BUILDING A MEMORIAL THAT CAN BE SEEN FROM SPACE (MY PERSONAL PREFERENCE RATHER THAN A WATER FEATURE) WOULD GIVE ME SOME SOLACE. I DO NOT LIKE THAT RIGHT NOW IT FEELS LIKE THE ONLY WAY THAT THIS IS TALKED ABOUT IS IF SOMEONE SEEKS OUT INFORMATION AND THEN, AS A PARENT WHO HAS EXPERIENCED THIS AFTER TAKING MY CHILD TO THE MEMORIAL AT CLARK COUNTY MUSEUM, HAS BEEN ACCUSED OF BEING "MORBID". AGAIN, RIGHT NOW I FEEL LIKE IT'S MANDALAY BAY, AND LAS VEGAS' DIRTY LITTLE TOURISM AFFECTING SECRET. SO ANYTHING THAT CAN CHANGE THAT INTO A NARRATIVE ABOUT THE INNOCENT VICTIMS, AND THE STORIES OF EVERYDAY PEOPLE BECOMING HEROES...I AM BEHIND IT.

WE VISIT LAS VEGAS AROUND FIVE TIMES A YEAR TO GO TO CONCERTS AND THIS WAS SO HORRIFIC THAT I WAS APPREHENSIVE ABOUT RETURNING BUT WE DID FOR A CONCERT AND EVERYTHING WAS FINE AND SINCE THEN WE MOVED HERE I. 2019

WE WERE AT THE CONCERT FOR THE FIRST 2 DAYS BUT DID NOT ATTEND THE SUNDAY CONCERTS BECAUSE OUR DAUGHTER CAME TO TOWN FOR A VISIT.

WE WERE AT THE HOCKEY GAME. WE HAD COME HOME AND FAMILY MEMBERS HAD CALLED US TO MAKE SURE WE WERE SAFE. WE SPENT THE NEXT 24 HOURS LOCATING FRIENDS AND FAMILY WE KNEW WERE THERE.
