 - b. Speakers must clearly state their name (last name spelled for the record) and address. No action may be taken on a matter not listed on the posted agenda. If any member of the Art Committee wishes to extend the length of a presentation, it may be done by the Facilitator or the Committee by majority vote.

- V. Budget Presentations – to allocate \$663,032 to new and existing budgets (*for possible action*)
 - a. Review Proposals
 - i. South West Ridge – Proposal is for a 6’ in diameter sculpture at the front of the park and various other artwork(s) on the trails of South West Ridge. Proposed budget of \$100,000.
 - ii. Pearson Community Center Pillar Mural Project – Proposal is for each of the 25 pillars to be painted. Pillars are located inside the Community Center. Proposed budget of \$53,100.
 - iii. Zap 12 Mount Charleston – Proposal is for up to 12 utility boxes to be painted. Proposed budget of \$12,000.
- VI. Report by Clark County Parks and Recreation Public Art Office staff regarding monthly summary of current projects – All Districts (*not an action item*)
- VII. Discussion regarding topics for future agenda items by the committee members.
