ORDINANCE NO. 5021
(of Clark County, Nevada)

AN ORDINANCE AUTHORIZING THE ISSUANCE OF THE "CLARK COUNTY, NEVADA, GENERAL OBLIGATION (LIMITED TAX) FIRE STATION AND TRAINING CENTER BONDS (ADDITIONALLY SECURED BY PLEDGED REVENUES), SERIES 2023," IN THE MAXIMUM PRINCIPAL AMOUNT OF \$50,000,000 FOR THE PURPOSE OF FINANCING THE ACQUISITION, IMPROVEMENT AND EQUIPPING OF BUILDING PROJECTS IN THE COUNTY, INCLUDING BUT NOT LIMITED TO PUBLIC BUILDINGS FOR A FIRE STATION AND FIRE TRAINING CENTER; PROVIDING THE FORM, TERMS AND CONDITIONS OF THE BONDS AND OTHER DETAILS IN CONNECTION THEREWITH; PROVIDING FOR THE LEVY AND COLLECTION OF ANNUAL GENERAL (AD VALOREM) TAXES FOR THE PAYMENT THEREOF; ADDITIONALLY SECURING THEIR PAYMENT BY A PLEDGE OF CERTAIN REVENUES; PROVIDING OTHER MATTERS RELATING THERETO; ADOPTING IT AS IF AN EMERGENCY EXISTS; AND PROVIDING THE EFFECTIVE DATE HEREOF.
